# Adventures in Opportunities

A Nebraska Homeschool Odyssey



In this issue we want to help you understand how Nebraska Homeschool functions. So join us on this Nebraska Homeschool odyssey, learn how things are currently run, and explore new and exciting opportunities for you to share your talents with fellow homeschoolers – all to the glory of Christ.

Nebraska Homeschool is a nonprofit organization that is governed by **a Board of Directors (BOD).** 

As a nonprofit, we are required to follow federal and state laws specific to nonprofit groups. At this time the BOD doubles as the Executive Committee, and the president wears the hat of the Executive Director for the nonprofit.

Any homeschool parent may volunteer to serve on our BOD, but the sitting BOD must vote on the new candidates as specified in our bylaws. Board terms are a minimum of two (2) years and board members may be re-elected to the BOD in subsequent years. At this time there are no term limits, but this may change as more members become involved. Each board member must sign an agreement to serve and other documents pertaining to the following items: board loyalty, conflict of interest, privacy and propriety protections, the vision, mission, core values, Statement of Faith, and Position Papers. NH-HEN requires these agreements from the BOD in order to maintain group integrity, a focus on vision, a unity in service, and to ensure consistency of message to the homeschool community that we serve.

At this time our BOD consists of four individuals, but *we would like to have six people serving on the board*. Having more board members generates more ideas and brings energy to the board, plus it helps share the workload. We meet an average of ten times per year and hold ad hoc meetings when necessary. Much work is conducted via email and telephone. *We are seeking three (3) more members for the Board of Directors.* 

#### What do board members do?

All board members attend board meetings and perform duties specific to their offices, participate in strategic planning, conference planning, board training, community engagement, fundraising, networking, and mentoring. These activities encompass many things, plus there are other key areas of operation that need our attention.

To keep our group running smoothly, we find it works best when we have one person spearhead efforts related to a specific area. This helps prevent duplication of effort while attaining synergy of effect. Much of what the BOD does <u>can</u> be done by member volunteers. In fact, we'd love to see more members step into leadership roles. When volunteers are scarce, the board members' duties increase. If member

volunteers remain few, our board is forced with the decision of cutting programs and services. This is why it is so important for each member family to help out in some way. If you value our programs and services, please help us sustain them. When we all contribute in some way, no one family is over-taxed and our entire group benefits from robust programs and services—in fact, we actually thrive and can begin to entertain the idea of creating new programs for our members. **Chart B** (on next page) shows who is spearheading a key area, and it clearly highlights the areas where help is needed. *Items in blue show the transition plan for 2018. #### Does Nebraska Homeschool have any committees?

Nebraska Homeschool has one (new) committee – the **Governance Committee**. A minimum of two BOD members must serve on this committee along with members. Kevin and Tamara recently joined the committee and we'd love to have one more person join. The role of this committee is to research issues, develop products (forms, programs, etc.), develop proposals, and make recommendations to the BOD. The Governance Committee is accountable to the BOD and submits recommendations to the BOD for review and approval. The Governance Committee also offers members a

### What benefits come with serving?

As an all-volunteer organization, we don't have paid staff nor can we afford any at this time, but we do look for ways to show our appreciation to our volunteers. All BOD and Governance Committee members enjoy **waived membership fees** while serving. Individuals who serve a term as president are granted a lifetime membership. We try to compensate select program leaders when possible. Compensation of waived membership fees is determined in part by the level of commitment required for a program and by our annual budget.

We also strive to help our volunteers build individual knowledge and skills that can be used in a variety of settings <u>and listed on professional resumes</u>. All volunteers with NH-HEN can take advantage of **free (or discounted) nonprofit training**. Training is offered through the *Nonprofit Association of the Midlands (NAM)* and is applicable to a variety of work and nonprofit settings.



Nebraska Homeschool has qualified for *G Suites for Nonprofits* (part of Microsoft's Google platform). This is good for our group because we can accomplish <u>many</u> administrative functions within that platform. G Suites for Nonprofits resources offer NH-HEN many possibilities...ones that we're still exploring. One huge advantage of our G Suites, we now have **organizational emails** at no cost to our group or to our volunteers. In the near future, all of our program leaders will have an email with the *@nebraskahomeschool*.org address. This keeps the homeschool group business in the group, retains a historical record, represents us to the public, and eases transition when leadership changes – PLUS it keeps group business out of personal email boxes. (Heaven knows we all get enough email at home!)

Nebraska Homeschool has also qualified for *TechSoup* –a discounted technology forum for nonprofits. We purchase **discounted software and hardware for our nonprofit use.** This frees up group funds for other programs and services. *We can extend this savings to our volunteers so they can enjoy the same discounts while they serve in NH-HEN programs.* 

### Are there other service opportunities?

Absolutely, yes! Every program and service we provide needs a leader and several need additional workers. This is where members (both old and new) can jump in and help. As we improve use of our website, G Suites platform, and TechSoup benefits, we will be seeking to automate as much of the workload as possible. We hope to lighten the workload for our volunteers. We want all of our volunteers to have the joy of serving and not feel burdened. **Chart D** provides a list of our current programs and services along with the current program leaders. *Items in red show where we need volunteers. Please note time commitments are estimates. Needs are immediate unless otherwise stated.* 

Opportunities to serve abound! We encourage each of our member families to adopt a bold spirit of adventure and jump in. Help us serve the Nebraska homeschool community.

Each member family will be able to set personal preferences for forum participation in the Member Profile. Families who don't want to participate in forums may opt out in the Member Profile.

New forums will be added as the need dictates AND as moderators step up to assist. For starter, NH-HEN is seeking two (2) moderators for the Member Mentor forum...this first forum that will be rolled out in April and will focus on offering support to members with homeschool questions and concerns. All members are encouraged to participate in this first forum.

# Legal to Homeschool in Nebraska

It was in July 1977 when a period of great turmoil and persecution started for several Nebraska church schools and homeschooling families. It continued into 1984. Thanks to Lorraine Lostroh, Nebraska Christian Home Educators Association (NCHEA) executive committee member, many important details have been recorded in a booklet entitled *Victory in Jesus: The Battle for Christian Educational Freedom in Nebraska 1977-1984* (2002). Her booklet provides an overview of key events by cataloging state actions and

legal outcomes during that time. It also lists the names of many Christian parents who fought to educate their children according to Christian convictions. It was the faithfulness of these parents that won homeschooling freedom for all Nebraskans.

Many of the churches and families mentioned in the booklet encountered arrests, court proceedings, financial burden, loss of personal property, and loss of freedom when pastors or parents were jailed. Many families were threatened with the loss of their children and at least one family did experience placement of a child in foster care for a short period of time. Several families fled the state to ensure their children would not be taken away – all of this because they wanted to educate their own children. It's hard to fathom this happened right here in Nebraska in the late 1970s and early 1980s. It hits home even more when I realize that I had just completed my own home education right in the middle of this same timeframe. How blessed our family was to be living in a state where homeschooling was legal. *How blessed I am NOW to live in a state where it is legal to homeschool my own children!* 

As a result of those brave and faithful families' actions, the Nebraska legislature passed LB 928 in the spring of 1984 making church schools and homeschools legal by allowing for an exemption from state requirements for approval or accreditation *for the sincerely held religious beliefs of the parents (or guardians).* The following August the NE Department of Education published the first version of NDE Rule 13 defining how the law would be implemented through their agency. Even though Mrs. Lostroh's booklet ends at this point in Nebraska's homeschooling history, God continued to build upon the foundation that was set. Other parents began to ask if they could homeschool for other reasons. This eventually led to an amendment to the law in 1999 providing an alternate reason for electing exemption—if the state's *requirements interfered with parental decisions in directing their child's education*. Another victory! Following that amendment, NDE Rule 12 was published. The two rules were virtually identical with the exception of the reason for electing exemption and some immunization requirements.

In reflection, I see God's hand at work over the past 40 years in Nebraska. He provided for us, even before we knew we had a need. Praise to God and much gratitude for the Christian families who carried the banner for us. If you attend the NCHEA conference this spring, be sure to look for Mrs. Lostroh's poster presentation of original newspaper articles displaying the stories of struggle and you can also pick up your own copy of her booklet.
